DESIGNATION AS IMPAIRED INSURERS UNDER
TEXAS INSURANCE CODE CHAPTER 462

General remarks and official action taken:

On this day came on for consideration by the Commissioner of Insurance the matter of Atlantic Mutual Insurance Company ("Atlantic Mutual IC") and Centennial Insurance Company ("Centennial IC") organized in New York and doing business in the State of Texas. On April 27, 2011, the Supreme Court of the State of New York, County of New York entered an *Order of Liquidation* for each company in Index No. 402424/10, finding Atlantic Mutual IC and Centennial IC to be insolvent.

Based upon the finding of insolvency by the Supreme Court of the State of New York, County of New York, and having considered the purposes of TEX. INS. CODE Ch. 462, the Commissioner of Insurance finds that Atlantic Mutual IC and Centennial IC should be, and are hereby, designated as impaired insurers as that term is defined in TEX. INS. CODE § 462.004(5), effective April 27, 2011.
